RULES AND PROCEDURES

1. All GHS school rules, policies, **DRESS CODE**, and direction of school personnel are in effect during the dance for both student and guest. If there is a question about **DRESS CODE**, consult with an administrator one week prior to the dance.
2. A signed copy of this approved guest pass and copy of the guest's photo ID must be presented when purchasing the guest's ticket to the dance. The guest pass will be kept in a file and checked upon entry to the dance.
3. Both the GHS student ID and the guest photo ID must be presented at the door with tickets.
4. One guest per GHS student.
5. Approval of a guest is based on both student and guest discipline and behavior history.
6. The guest must be accompanied by the GHS student listed on the pass when entering the dance.
7. Bringing a guest to a dance to be the date of another guest is not allowed.
8. Zero tolerance for drug and/or alcohol use. Any dance attendee may be subject to a breath analysis and/or search. Disciplinary action may include suspension, police/parent contact, and exclusion from future dances.
9. **DRESS CODE AND APPROPRIATE DANCING WILL BE ENFORCED.** Inappropriate dancing includes freak dancing, grinding, explicit sexual gesturing, lewd misconduct, and provocative or sexually suggestive in nature.
10. With the exception of rule #9, one warning will be given if any of the other rules or procedures are broken. Upon the second infraction of a rule or procedure, the student(s) and guest(s) will be removed from the dance. Refunds will not be given if removed from the dance.
